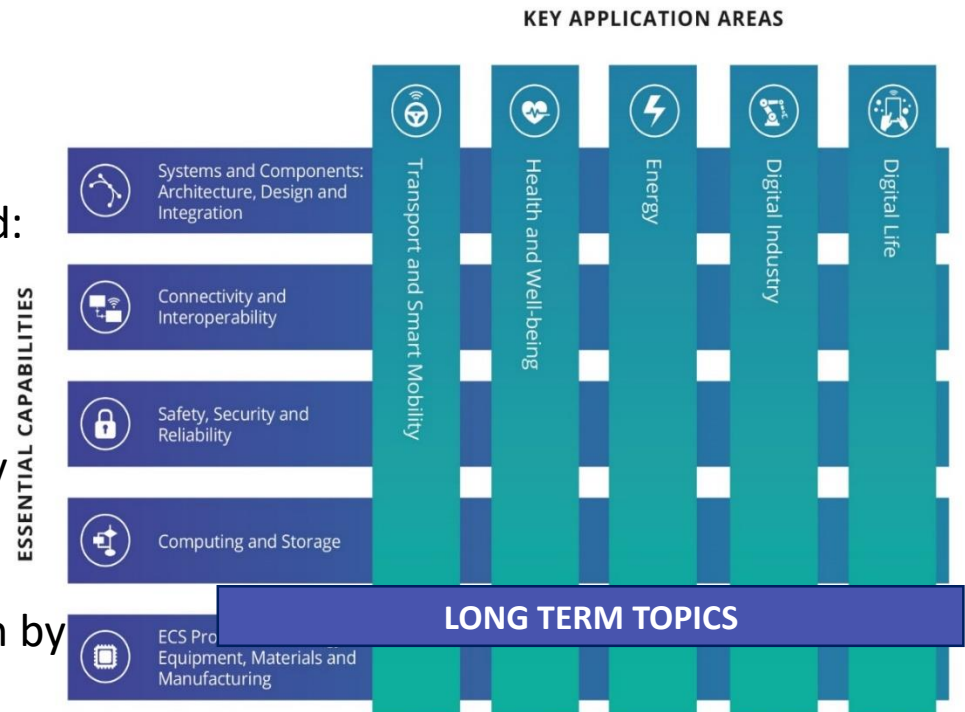


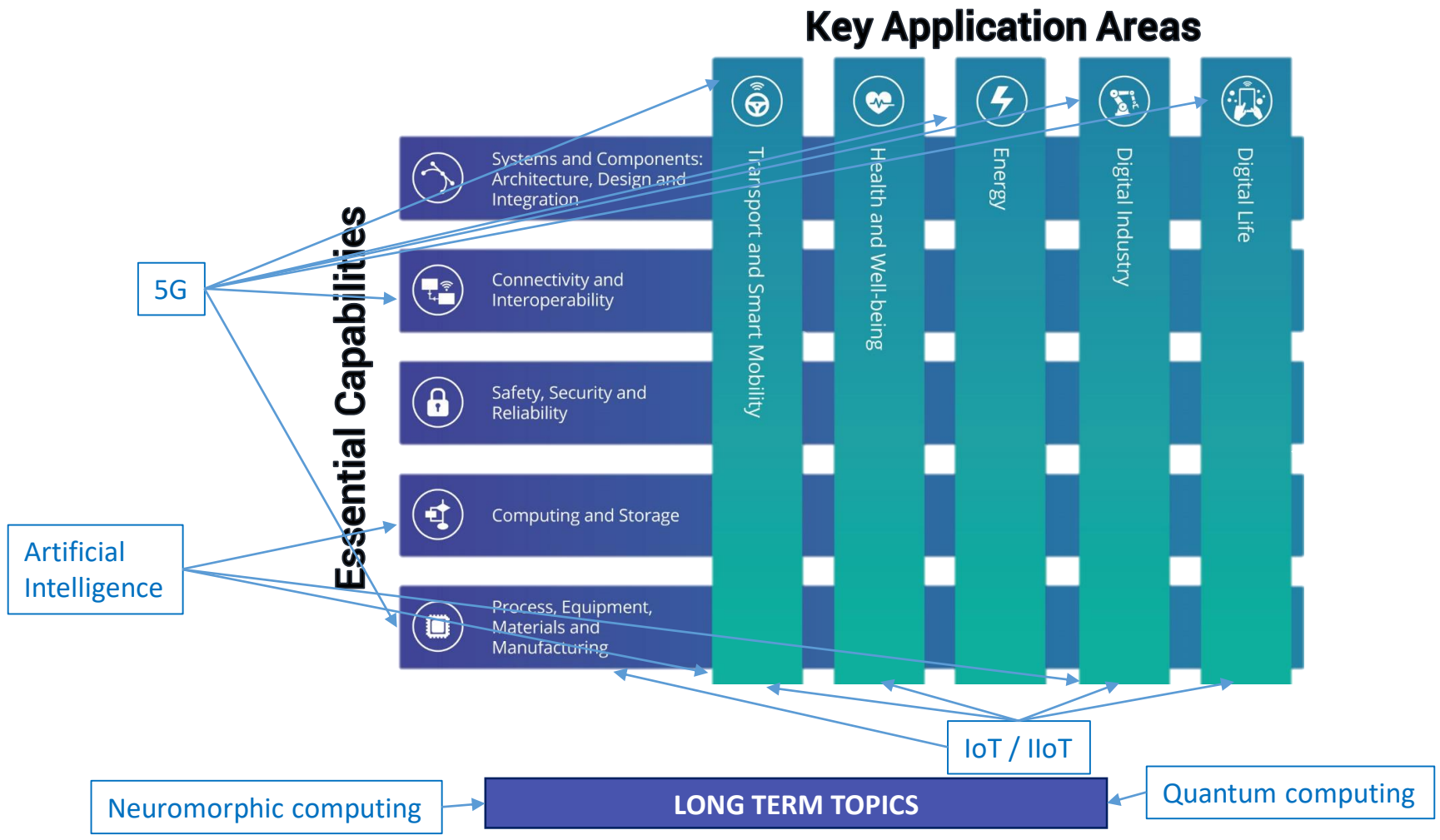


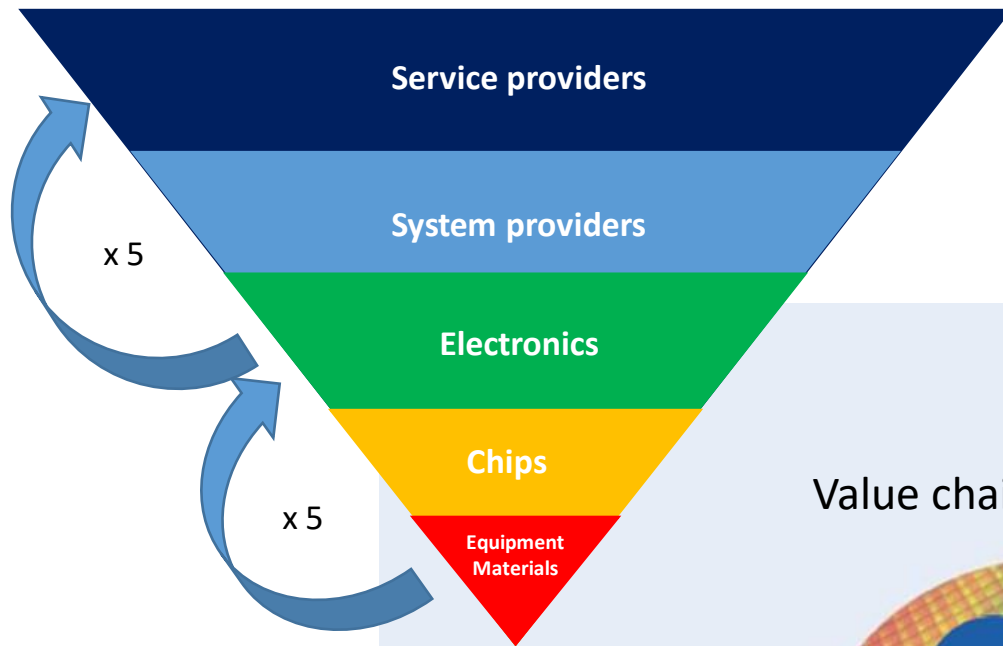
ECSEL Participating States: EU Member States and Israel, Norway, Switzerland and Turkey

A common strategy: Strategic Research Agenda (SRA)

- SRA is prepared by 3 Industry Associations (not only large companies but also SMEs, Universities, RTOs)
 - AENEAS
 - ARTEMIS-IA
 - EPoSS
- SRA is adopted by the Governing Board: SRA becomes MASP (Multi Annual Strategic Plan)
- MASP is the foundation to built up the ECSEL JU Annual Work Plan adopted by the Governing Board
- ECSEL JU Calls launching decision taken by the Public Authorities Board

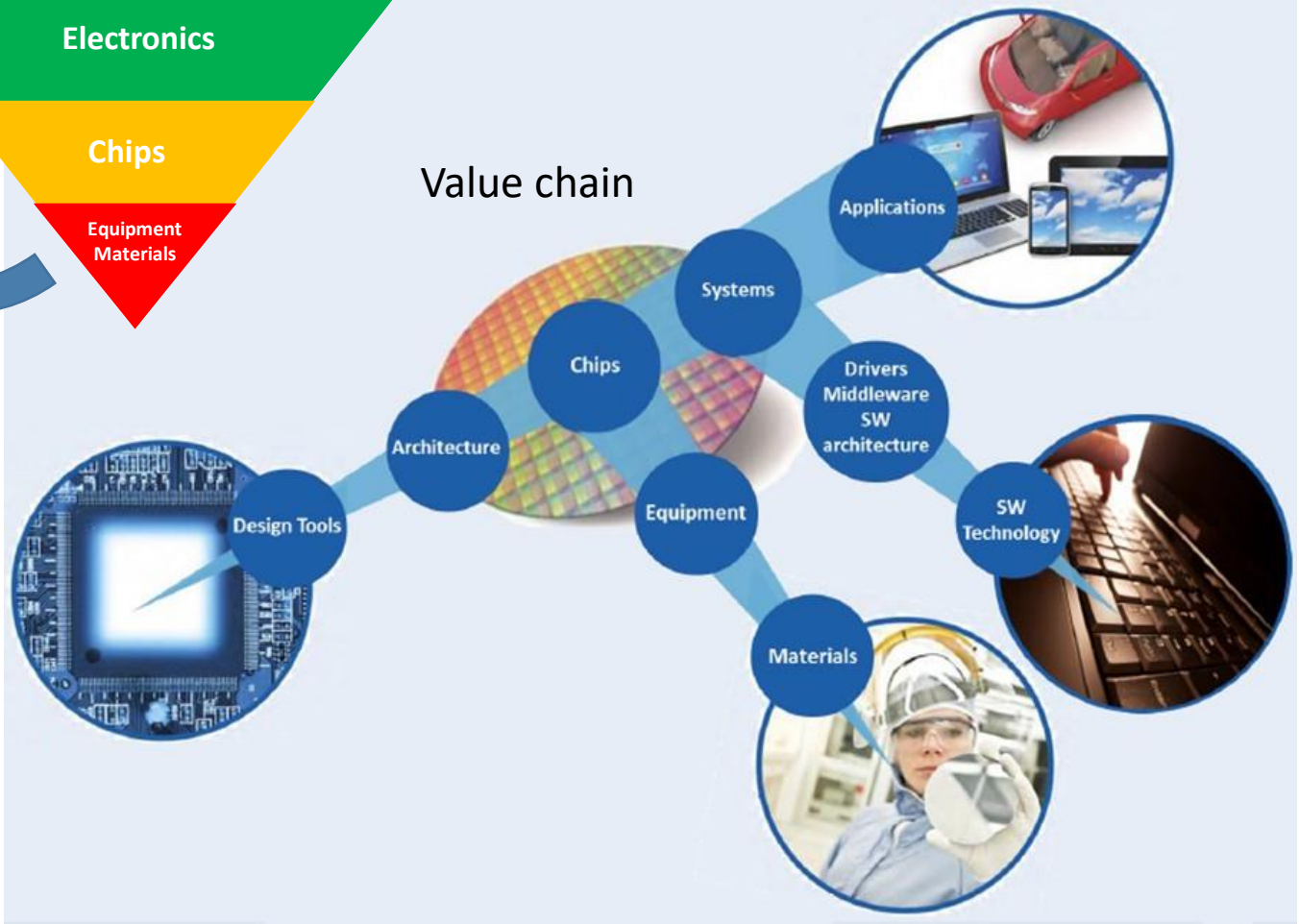

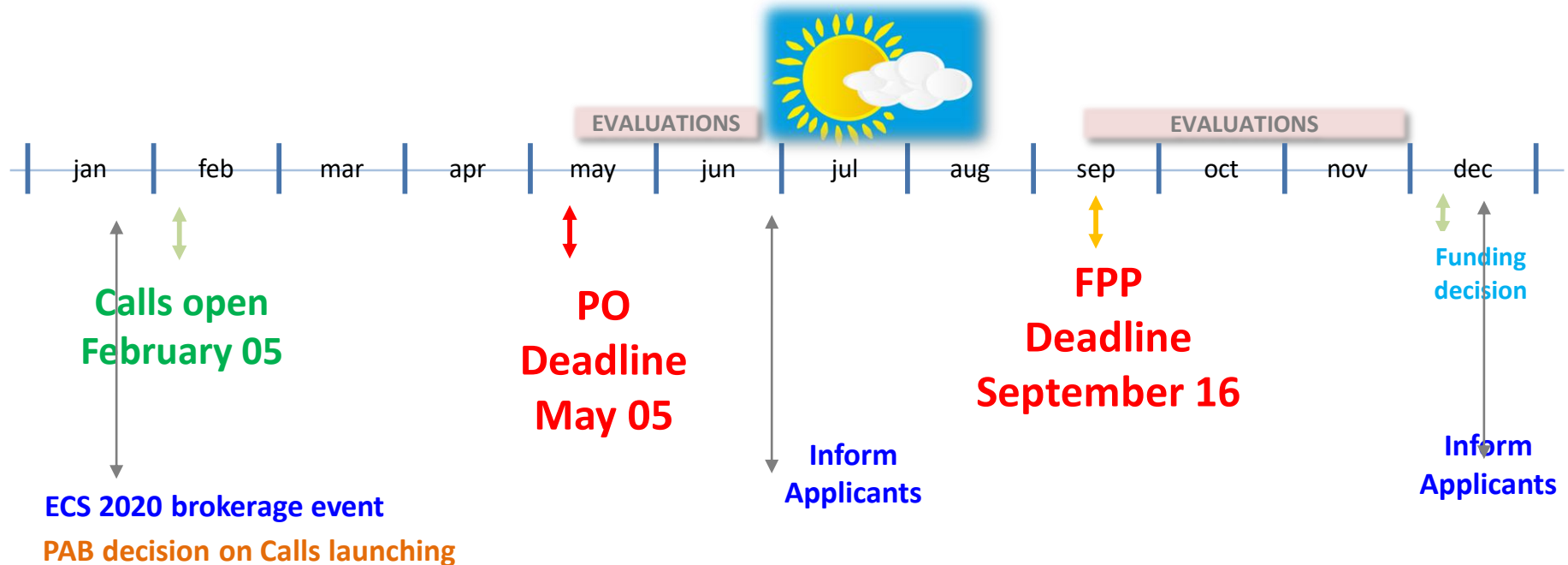

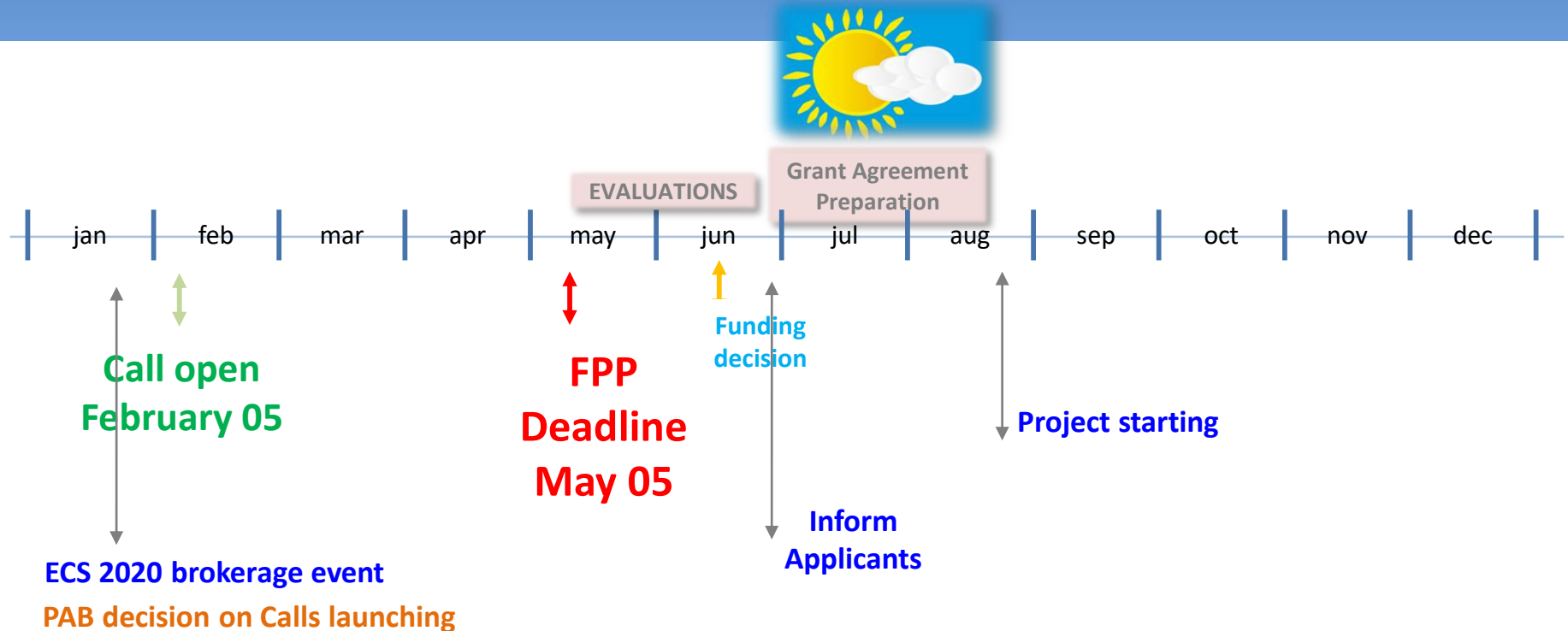

MASP 2020 GRAND CHALLENGES

4 general changes as compared to 2019:

- **Technology developments for Artificial Intelligence** were added in all sections
- **Integrated photonics** and **flexible electronics** added in introduction
- The **reduction of energy consumption** of ECS was stressed as key for digitalization and broad implementation of Artificial Intelligence
- In the whole document additions with focus on **software technologies** and **edge computing** were made



Annual Work Plan – highlights

- Aspects of **ECS value chain integration** are important for the ECSEL programme and the whole European ECS sector, across applications and across capabilities. Consortia are encouraged to submit proposals that take this aspect into account.
- Along the lines of the previous bullet, proposals that **cut across disciplines, support platform building, interoperability, establishment of open standards** are particularly encouraged; even outside the regular ECS sector.
- Description of **the important challenges** as proposed by the LIASEs of the **ECSEL Lighthouse Initiatives** and by **DG-Energy** in the fields of Mobility, Digital industry, Health and Energy are provided in annex 9; **these challenges are of special relevance** and proposals for the Call 2020 supporting these topics are strongly encouraged.
- For the Call 2020, **proposals supporting specific aspects of ‘edge computing’ are particularly encouraged.**

- RIA-IMI-Call description is presented in the Annex 7 of the [ECSEL WorkPlan 2020](#)

National limitations might be applicable (section 10 of [ECSEL JU Work Plan 2020](#)) – check regularly the updates!



IA & RIA Calls RECOMMENDATIONS

- **SMEs** should be encouraged to participate to the proposals in a **significant way**
- The consortia proposing projects will **strive for a ratio** of the total national funding to the EU funding larger than **1.20**.
- IA: Partners are **encouraged to create visibility to promote the developed technologies outside of Europe** creating the basis for European impact on future international markets



IA, RIA, RIA IMI-ECSEL

ELIGIBILITY CONDITIONS

1. **AT LEAST THREE LEGAL ENTITIES.** Each of the three must be established in a different Member State or associated country. All three legal entities must be independent of each other (*automatically checked by the submission system - warning!*)
2. **PROJECT DURATION IS LIMITED TO 3 YEARS**
3. **SIZE MAXIMUM:**
 - IA: **90** PARTICIPANTS
 - RIA: **50** PARTICIPANTS
 - RIA IMI-ECSEL: **50** PARTICIPANTS

ELIGIBILITY CONDITIONS

4. CAPPING of BUDGET:

- **IA:** The **EU contribution per project** is capped at IA= **25M€** and the **maximum contribution per partner** in a project is limited to IA= **50%** of the total EU funding for the project
- **RIA:** The **EU contribution per project** is capped at RIA= **12M€** and the **maximum contribution per partner** in a project is limited RIA= **40%** of the total EU funding for the project
- **RIA IMI-ECSEL:** The **EU contribution per project** is capped at RIA= **5M€** and the **maximum contribution per partner** in a project is limited RIA= **40%** of the total EU funding for the project

At PO for 1: EXCLUSION, for 2,3,4 WARNING (*feedback from ECSEL office!*)

At FPP for 1,2,3,4 EXCLUSION (NO EVALUATION) WILL BE STRICTLY APPLIED!!!



Additional conditions

- Financial support to third parties is allowed for IA, RIA and RIA-IMI-ECSEL calls but it is capped at (limited to) 3% of the EU funding requested by the proposal
- Participants to ALL ECSEL Calls are required to conclude a Consortium Agreement prior to the start of the project

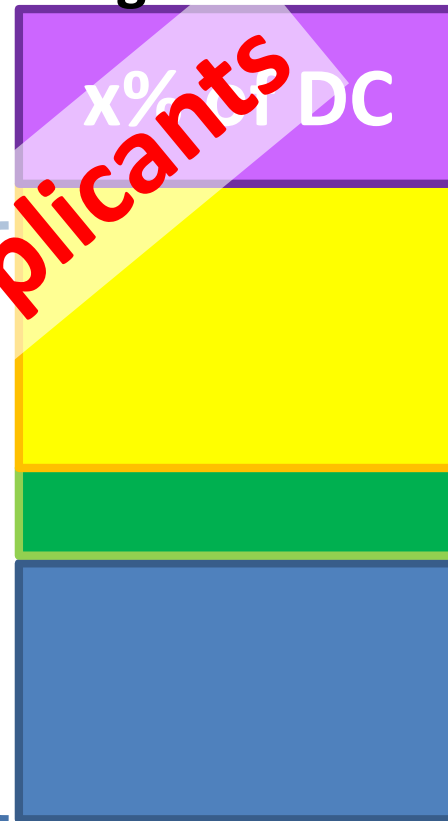

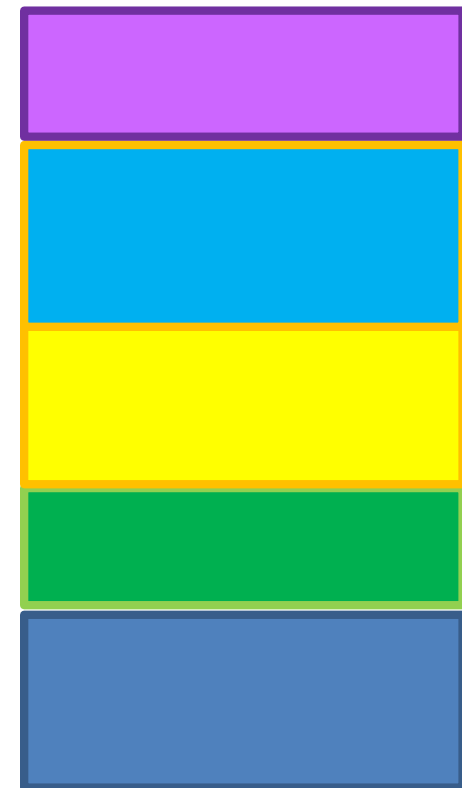

ESI Funding

European Structural and Investment (ESI) Funding

- If activities with costs are funded through ESI funds, then those activities **cannot obtain ECSEL-EU funding**.
- Various possibilities to include activities funded by ESI funds described in the Guide for Applicants
- Main issue: **no overlap**
- Risk mitigation: what happens if the activity does not get the ESI funding?



EU Reimbursement rates

The **MAX** funding percentages of the EU contribution are **different than under H2020**.

Type	IA	RIA	RIA-IMI-ECSEL	CSA
For profit (non SME)	20%	25%	25%	100%
SME	25%	30%	30%	100%
University/Other	35%	35%	35%	100%

EU Contribution as % of the eligible cost according to H2020 (beneficiaries may ask for a lower contribution)

National contributions: vary per state, see Section 10 of ECSEL JU Annual Work Plan 2020! **Contact the national authorities to inquire about specificities, limitations!**



Scoring and ranking

- At PO stage the score resolution is 0.5 and at FPP 0.1
- CSA Call score resolution is 0.5
- The different calls have different thresholds AND different weights.
- The thresholds determine if a proposal is “selectable” or not.
- The weights determine the ranking of the proposals above thresholds (at FPP stage)
- At the PO phase NO ranking is established
- The experts’ ranking and scoring at the FPP is transmitted to the PAB for final decision.
- The ranking of the proposals can change after the PAB voting to align with the national strategies and priorities

Proposal submission



- Proposals must be complete:
 - **Part A:** administrative information including financial information (costs, funding) – filled in “online” each beneficiary can fill in its own data; ethics questions as well as specific ECSEL questions and “opt-out” of the [Horizon 2020 Open Research Data Pilot and Data Management Plan](#)
 - **Part B:** technical description – upload as pdf file (**mandatory** to use the provided Template!) – different from H2020 standard template! A model on both on ECSEL website and funding portal; template available in the submission link after creating the draft proposal
 - **Part(s) C (specific for ECSEL): country specific information;** upload a password- protected zip file for each country by using the dedicated placeholder; email the ECSEL office to get the password (calls@ecsel.europa.eu)



IA, RIA, RIA-IMI Calls

Mandatory Page Limits

- Use the default template and fonts!
 - Chapter **EXCELLENCE** - 60 pages (both PO and FPP stage)
 - Chapter **IMPACT** - 60 pages (PO stage) 100 pages (FPP stage)
 - Chapter **IMPLEMENTATION** - 60 pages (PO stage) 100 pages (FPP stage)
- Sections on participants description, ethics, public summary are excluded from the page limit
- The page limits and sections subject to limits are clearly indicated in the proposal templates.
- Expert evaluators will be instructed to disregard the excess pages.



CSA Digital Excellence Call

Mandatory Page Limits

- Use the default template and fonts!
 - Chapter **EXCELLENCE - 30 pages**
 - Chapter **IMPACT - 30 pages**
 - Chapter **IMPLEMENTATION - 30 pages**
- Sections on participants description, ethics, public summary are excluded from the page limit
- The page limits and sections subject to limits will be clearly indicated in the proposal templates.
- Expert evaluators will be instructed to disregard the excess pages.
- ***One stage Call – all sections MUST be completed!***

The Project Outline (PO) IA & RIA

- **Blocking** if under threshold
 - Participants, budgets: **as complete and precise as possible BUT** changes are possible afterwards, though limited!
 - Part B of the Proposal to address
 - Section 1. **Excellence (complete)**
 - Section 2. **Impact (partial)**,
 - Section 3. **Implementation (partial)**
- Fill in as indicated in the template!



The Project Outline (PO) IA & RIA

- Fill in the other Sections *if available info*:
 - Section 4. Members of the consortium;
 - Section 5. Ethics and Security;
- Section 6. **Publishable Summary** (mandatory!!!)



ONLY Successful proposals (above threshold) invited to FPP stage!!!

Feedback to applicants PO stage: ESRs (subjected to PAB decision) + information about the national eligibility



Full Project Proposal (FPP) IA & RIA and RIA IMI-ECSEL

- Part B of the Proposal to be fully addressed
 - Section 1. **Excellence (complete)**
 - Section 2. **Impact (complete)**,
 - Section 3. **Implementation (complete)**
 - Section 4. Members of the consortium **(complete)**
(evaluated under operational capacity!)
 - Section 5. Ethics and Security **(complete)**
 - Section 6. **Publishable Summary** (mandatory!!!)
- **DO NOT FORGET:** *a draft plan for the exploitation and dissemination is an admissibility condition for FPP!!!*

PO AND FPP ARE TWO SEPARATE EVALUATIONS!!!



Open Research Data pilot

- Opting out does not affect the evaluation of your proposal
- Staying in – a data management plan must be provided in the Part B as indicated in the template;



Lighthouse Initiatives

- Calls 2020 do not foresee any new LI
- Joining an existing LI – via the LIASE



Proposal submission

- ✓ *Don't wait the last minute to submit the proposal! Part A requires a rather significant amount of data from each participant – start early! Your computer might need some adjustments (e.g. your firewall is blocking to fill in the Part A)*
- ✓ *Each participant needs to have a PIC number in order to be added to the consortium (only the coordinator can add participants to the consortium and only the coordinator can submit the proposal!)*
- ✓ *Make sure you use the correct link before starting to fill in the data: for example for a RIA special topic use the RIA special topic link as proposals cannot be moved from one call to another; if you used the wrong link you have to start all over again in the correct link!*
- ✓ *For a given proposal can be several submission sessions (the new version will overwrite the old version and only the newest version will be kept in the system)!!*
- ✓ *Caution when uploading documents (Part B/ Part(s) C) make sure the intended version was uploaded and not one stuck in your browser “cache”. Check after uploading – e.g. close the browser/login again and download the document!*



Proposal submission

- ✓ *Participants are recommended to check/update their legal data and fill in the data as appropriate as possible.*
- ☐ *If selected for funding the SMEs will be requested to do a self-assessment. If the results of self-assessment is that the respective participant is not an SME though it declared itself a SME when the proposal was submitted the funding will be adjusted accordingly (reduced to correspond to 'for profit non SME)*
- ☐ *If a participant is a non-for profit organization but at the proposal submission (FPP) filled in the funding rate of a for profit organization, during the GAP phase it will be very difficult to adjust (increase) the funding rate as the EU budget was already allocated.*
- ☐ *British participants are kindly advised to monitor the Funding and Tenders Portal for the most up to date information. ECSEL JU will apply the same rules as in H2020*

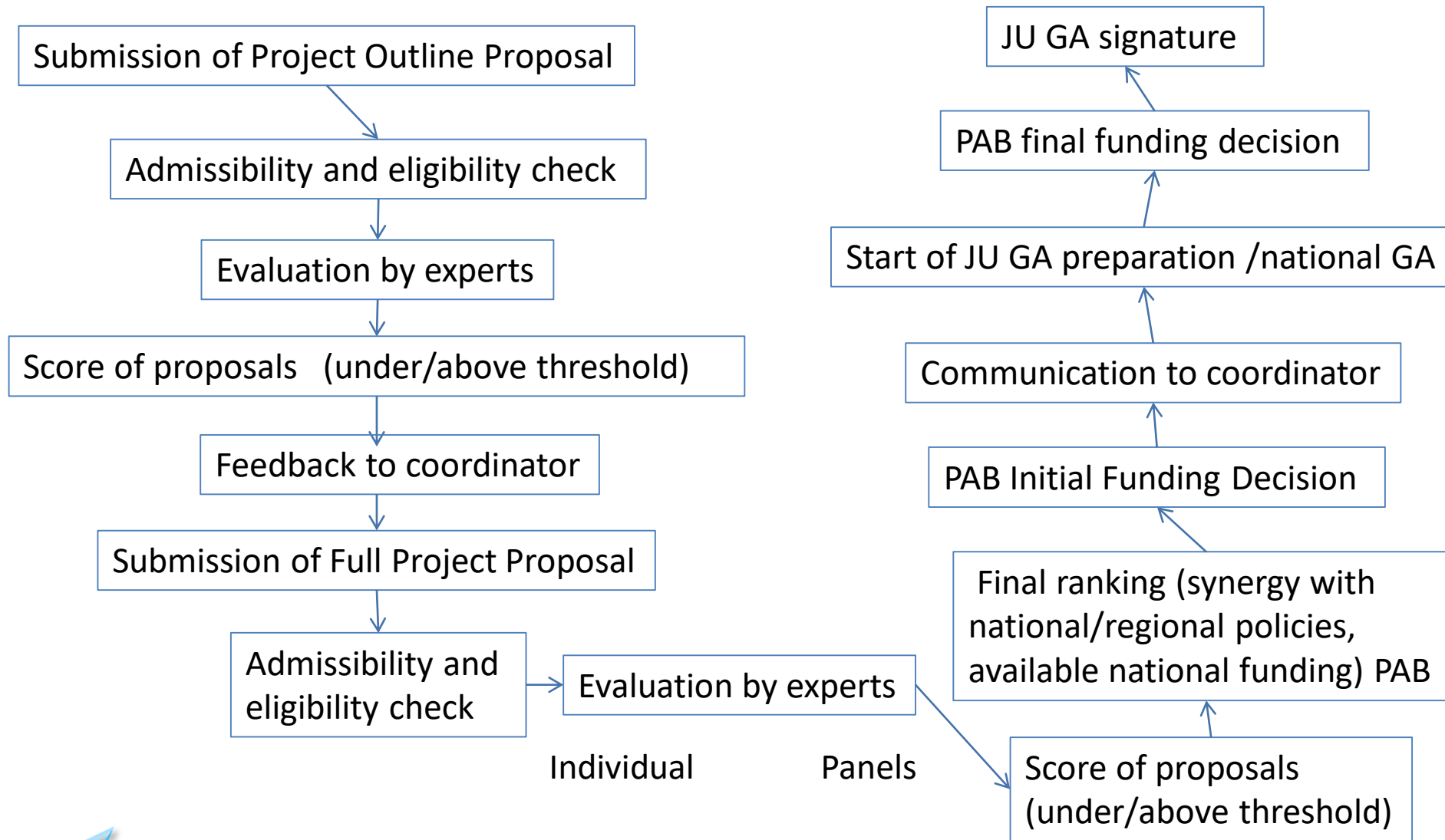


Proposal submission

- ✓ *Coordinators of proposals that request more than 500,000.00 € EU funding will have to undergo a financial viability check (except for public bodies, higher or secondary education establishments, international organization or body whose participation is guaranteed by the government of an EU country or associated country)*
- ✓ *Therefore the coordinators are advised to use the [self-check tool](#) available in the Participant Portal and in case of weak or insufficient financial capacity to already prepare an action plan*
- ✓ *Self-assessment forms are provided in the Calls Documents to help out the applicants*



From proposal submission to grant signature



Grant Agreement

- V2.0 for projects of calls 2014 to 2016
- V3.0 for projects of calls 2017, and via amendment also for calls 2014 to 2016
 - some simplifications for cost eligibility
- V4.0 july 2017
 - possibility for internal cost based on unit cost according to accounting rules of beneficiary
 - payment to researchers in frame of H2020 cannot be lower than national contracts (EU-13)
- V5.0 dec 2017 – from projects of calls 2017 onwards
 - Article 29.3 - “Open access to research data”
 - Articles 34 - “Ethics and research integrity”
 - Minor drafting changes and correction of clerical mistakes
